## SUMMARY ANNUAL REPORT FOR GENESCO INC. SHORT TERM DISABILITY PLAN

This is a summary of the annual report of the Genesco Inc. Short Term Disability Plan (Employer Identification Number 62-0211340, Plan Number 518) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Genesco Inc. has committed itself to pay certain temporary disability claims incurred under the terms of the plan.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$1,685,897 as of the end of plan year, compared to \$1,242,196 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$443,701. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$834,369 including employer contributions of \$295,550, employee contributions of \$317,655, gains/(losses) of \$0 from the sale of assets, and earnings from investments of \$221,164. Plan expenses were \$390,668. These expenses included \$6,617 in administrative expenses, \$384,051 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
